Subject: Allocation of physical targets for setting up small Biogas Plants under New National Biogas and Organic Manure Programme (NNBOMP) during 2020-21.

Sir/ Madam,

In continuation of this Ministry's Administrative Sanction-cum-Guidelines issued vide letter No. 253/16/2017-BIOGAS, dated 30.05.2018 and subsequent letters of even number dated 25.10.2018, 25.02.2019, 08.04.2020 and Scheme (NNBOMP) continuation letter No. No. 253/16/2017-BIOGAS, dated 11.06.2020 for the 2020-21, I am directed to convey the approval of the competent authority for allocation of the physical target for setting up small biogas plants during the current year, 2020-21 under the NNBOMP as per the same terms and conditions as given in the above mentioned Administrative Sanction-cum-Guidelines of the Scheme and its addendums as conveyed to all the designated Programme Implementing Agencies (PIAs) of NNBOMP vide this Ministry's letters as mentioned above. The State-wise & UT-wise and PIA-wise physical targets for setting up small biogas plants of size 1 M³ to 25 M³ and conducting various training courses are given in **Annexure-I** enclosed along with this.

2. Accordingly, all the concerned designated PIAs of NNBOMP viz. State Rural Development Departments (SRDDs), State Nodal Departments/ State Nodal Agencies (SNDs/SNAs), National Dairy Development Board (NDDB), and KVIC are requested to take immediate steps to finalize the implementation planning and start implementation of the scheme to ensure achievements of the allocated physical targets in full with quality material & construction, completion, proper commissioning of plants & their certification and functioning of biogas plants and follow all the terms and conditions of the Scheme as per the above mentioned Administrative Sanction-cum-Guidelines of the NNBOMP dated 30.05.2018 and its subsequent amendments/ addendums as mentioned above, until any further change(s)/ amendment/ addendum made by this Ministry.

3. This issues with the concurrence of Internal Finance Division (IFD) of this Minister vide their Dy. No. 121, dated 23.07.2020 and approval of the Competent Authority, Hon'ble Minister of State (I/C) for Power, New and Renewable Energy & MOS for SDE, Government of India.
